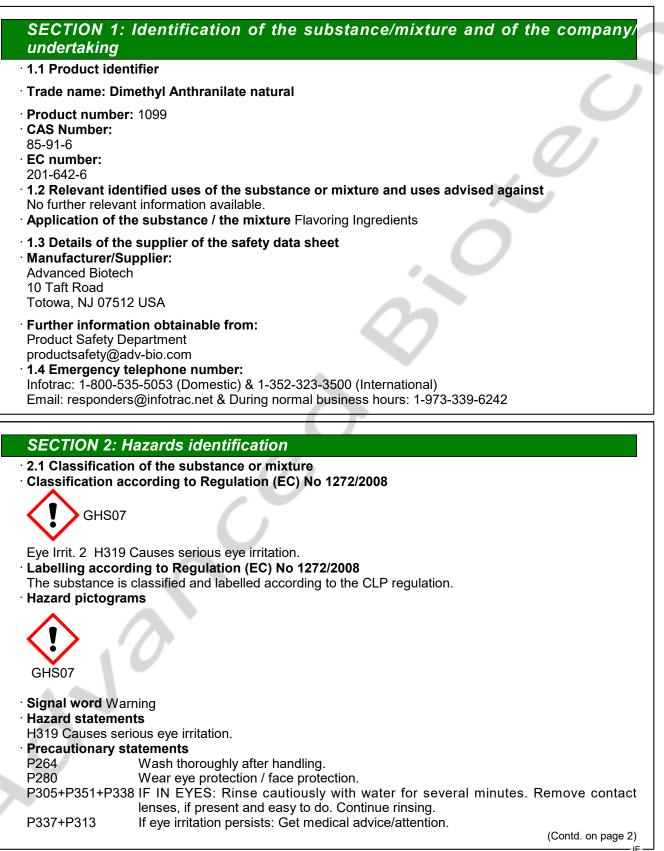

Protective gloves
