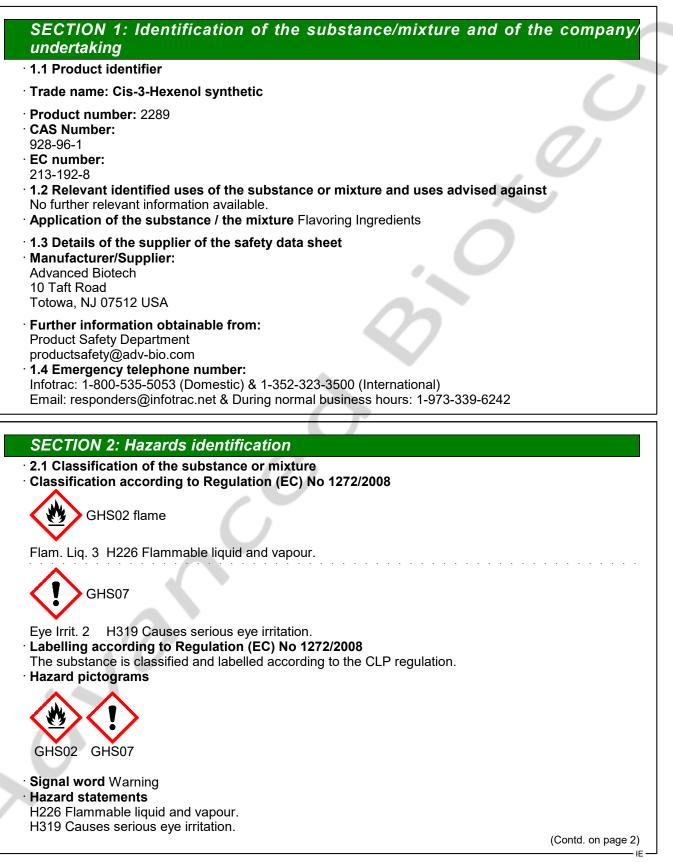

Protective gloves
